08 Deep Creek Lake Bass Final Sat. October 4th, 2008 7AM-3PM (No Entry Fee for top 10)

Off weeks are June 26<sup>th</sup>, July 3<sup>rd</sup> and September 4<sup>th</sup>.

Entry fees are \$50.00 per boat per week.

Points will be by your teams best 10 tournaments.

### Tournament Rules:

The following rules shall apply and will be enforced. Interpretation and enforcement of these rules shall be left exclusively to the tournament director or his designee (Director: Justin Hershman). In the event of a rule violation, the tournament director may impose such sanctions, as he deems appropriate, including, without limitation, disqualification, and forfeiture of prizes, points and/or entry fees. The decision of the tournament director or his designee shall be final in all matters.

1. Completed registration form for your teams anglers must be filled out at your first tournament.
2. Check in each week is from 4:30 to 4:55. If you are going to be late for any reason and want to fish you must call either Bill's Outdoor Center or someone in the tournament by 4:55 to have your names added to the sign up sheet that week (you may only do this if we have a registration form on file for that boater and non-boater).
3. The tournament director reserves the right to change and/or modify the rules at any time as well as DENY any applicant at any time.
4. The tournament is for largemouth and smallmouth bass only.
5. Minimum length is 12 inches as measured on a FLATBOARD Short fish will be assessed a 1 pound penalty from total weight and loss of that fish.
6. Each team may weigh in a total of 5 fish.
7. If a tie exists we will combine the money and split it evenly. Points will we be split between the 2 places.
8. **ARTIFICIAL BAIT ONLY**
9. Payout will be by schedule below. Points will be awarded to team no matter who boater and non-boater is, also anyone can use a sub for 2 tournament if your partner can not be there, or fish alone as many times throughout as necessary.
10. It is the competitor's responsibility to abide by all state and local laws for the waters.
11. These tournaments are at your own risk and for your pleasure. Please be safe and have fun.

**PAY SCHEDULE (\$40.00 from each boat each week will go in weekly payout listed below. The other \$10.00 will be put in the end of year point's fund).**

1-5 boats is winner take all (less \$10.00 per boat for point's fund). Over 20 boats in a week \$20 from each boat over will go to winner and \$10 to second and \$10 to third.
